The Reading/Thinking/Writing Task

Students worked with half a dozen texts or so about the impact of social media on people, including on teenagers. All of the texts were relevant to the Focusing Question "Overall, what is the impact of social media use on children and teenagers?" Over a period of several weeks, the students read texts on both sides of this question with guidance, took notes on the content, and participated in a Socratic Seminar to consider the positive and negative impacts of social media. The instruction emphasized keeping an open mind on the issue, and using careful and logical reasoning to analyze evidence.

This is a question that requires inferential, cause-and-effect thinking and analysis of the texts, as well as synthesis in bringing evidence from multiple texts into a single well-focused and well-developed essay.

A platform called KidzVuz, co-founded by Rebecca Levey, is for kids seven to twelve to share videos. Kids were inspired to make videos beneficial to kids "who might feel slightly isolated to connect with other tweens and teens who share their same interests," so "if you are living in a small town and you're the only kid who loves musical theater, instead of feeling like a freak about it, you can go online and find all these other kids that love musical theater" (Wallace, 2014). Establishes and maintains a reasonably formal style throughout

Attempts to **support claim with reason and evidence** from texts: the reason (phones are becoming appendages is supported by evidence, though uncited. **Reasoning** is appropriate.

In conclusion, social media is having more negative than positive impacts on people today. It is harmful in several ways. The cons most definitely outweigh the pros in this situation. Social media is not being used for its intended purposes. To help people and to connect them to others.

Attempts to use a **counterclaim:** the counterclaim is acknowledged respectfully, but not developed using clear reasoning. The statement about cyberbullying has no evidence. (Note: at this grade level, counterclaim need only be acknowledged)

Provides a concluding section that follows from the argument presented: the writer attempts to reflect on the overall complexity of the topic.

Final Thoughts Gr 7 Argument: Approaching

Overall, this essay shows some understanding of the topic of the impact of social media, and the texts she used. The writer responds to the prompt ("What is the impact of social media?") with a clear but general claim. The writer develops that claim, supplying reasons and some relevant evidence. She does not cite evidence. In all evidence paragraphs, the writer attempts to use reasoning as she uses and explains the evidence, but there are gaps and her thinking is not always clear.

In the essay, the writer does use a counterclaim, which she attempts to develop, to support her claim (though this full counterclaim is above the standard for this grade level). This helps to show her understanding of the texts. The writer uses a largely respectful tone when acknowledging disagreement.

All of the writer's thinking is done within a clear structure, including clear transitions, that makes the thinking well-connected and easy for the reader to follow. The writer finishes with a reflective conclusion, but it is not clear to the reader how the reflection follows from the argument.

This writer would benefit from instruction in citing evidence. She would also benefit from more time orally talking through her reasoning so that its meaning is more clear.
